## **Data Use Policy**

Aerospace Information Research Institute, Chinese Academy of Sciences (hereinafter referred to as AIRCAS) features unrestricted access without charge to scientific data products shared by the Big Earth Data Center (hereinafter referred to as data products), in online, CD-ROM, and print formats. These data products include the results of the 17 Sustainable Development Goals and related indicators of the United Nations 2030 Agenda for Sustainable Development, as well as relevant data from natural and social science research, published by the International Research Center of Big Data for Sustainable Development Goals.

Users (including recipients of the data products and other natural or legal persons or unincorporated organizations who directly or indirectly acquire or use the data products or any part of them) are subject to this policy when downloading or using the data products.

## **1.** Scope of Applicability

1.1 This policy is applicable to the data products, including but not limited to metadata, entity data files and related documents, images and research outcomes.

1.2 The provision of any copyrighted content in the data products by AIRCAS does not imply any transfer of any copyright in such content. Users using such content shall obtain all permissions required from the rights holder prior to specific use of such content.

## 2. Purpose and Methods

2.1 Users may use the data products freely, non-exclusively and free of charge for scientific research, educational or informational purposes, including for photo portfolios, theses, monographs, textbooks, public exhibitions, computer graphics simulations, web pages and decision-making processes, etc.

2.2 Users shall indicate the source of the data product used in the format of dataset citation: data from Big Earth Data Center, Chinese Academy of Sciences (http://data.casearth.cn), but shall not express or imply in any way that the data products, services, or activities are endorsed or supported by AIRCAS or any of its employees or any provider of the data products.

#### 3. Disclaimer

3.1 All of the data products published by AIRCAS are on an "as is" and "as available" basis. While AIRCAS takes all available means and efforts to ensure the quality of its data products, AIRCAS does not guarantee the quality in any form, explicitly or implicitly, nor does it rule out the possibility of errors. For any information on the quality of the data products, users shall refer to the relevant documents.

3.2 AIRCAS shall not be liable for any interruption of access to the data products caused by force majeure such as network disconnection, withdrawal of the data product by providers, administrative decisions by Chinese administrative authorities, judicial decisions, or other objective factors. AIRCAS also reserves the right to

temporarily suspend or completely terminate the access to the data products at any time as appropriate to its own discretion.

3.3 In any case, neither AIRCAS nor any of its employees nor any provider of the data products shall be liable, directly or indirectly, to any user for any costs, expenses, claims, or demands arising out of the use of data products, whether such liability is based on a contract, tort, warranty, administrative decision, or judicial decision.

3.4 Neither AIRCAS nor any of its employees nor any provider of the data products shall indemnify, hold harmless, or exempt any user from its liability for any form of conduct or copyright infringement arising out of the use of the data products.

# 4. Legal Applicability

4.1 The establishment, validity, execution and interpretation of this Policy are governed by the laws of the mainland of the People's Republic of China (excluding the conflicts of law provisions).

4.2 In the case of any conflict between this policy and the law in force, the conflicting part shall be amended or reinterpreted under the provisions of the law, and other provisions shall remain in force.

# 5. Dispute Settlement

5.1 In case of any dispute arises out of this policy or the use of the data products, and both parties are unable to resolve it to their mutual satisfaction, the competent court of the mainland of the People's Republic of China will have jurisdiction over the issue. It's within the right of any party to file a lawsuit with the competent court of the mainland of the People's Republic of China. A verdict will be rendered in accordance with local law at the time of the incident.

## 6. User Acknowledgement

6.1 Before receiving, downloading, or using any of the data products, users must have read, understood, and fully accepted all the contents of this policy and agrees that this policy constitutes a legally binding between AIRCAS and its users.

6.2 Users must ensure that their use of the data products complies with the laws of the mainland of the People's Republic of China and promise not to commit any acts in violation of these laws as a result of their use of these data products.
